And the Survey Said!

The results are in! We still have some data crunching to do (which Richard Hopkins on Camellia has offered his crunching expertise) but the FSU Community Development class, headed up by Dr. Andrew Aurand of the Department of Urban and Regional Planning, did a wonderful job of surveying and reporting the survey results. What I liked particularly about the survey results is the class wove U.S. Census findings into it, making it even more useful.

Out of approximately 450 households, 112 returned a survey—constituting a response rate of around 25%. I'm no statistician but I think that's a very good response rate. That being said, the following results are based on responses. In other words, the survey results shouldn't be considered a hard and true representation of the neighborhood.

I could write a book about the results (and you can view the class's formal reports in their entirety on our website--www.wooddrives.com). But I thought I'd share some of the highlights here:

Real Estate Trends

- Turnover in the neighborhood has remained fairly low and stable over the past two decades, although our survey indicates a possible recent decline. In 1990, 33.3% of householders had lived in the same house for over twenty years (U.S. Census Bureau, 1990). In 2000, 39.3% of householders had lived in the same house for over twenty years (U.S. Census Bureau, 2000). However, in 2011, only 29.1% of our respondents had lived in the same house for over twenty years.
- 83.8% of respondents expressed that they had no plans to move. This low rate of residential mobility may indicate strong social ties within the neighborhood.
- Rental units in Woodland Drives have increased as proportion of occupied houses. In 2000, 12.2% of householders rented their homes, up from 4.3% in 1990 (U.S. Census Bureau, 1990, 2000).

Neighborhood Awareness

The survey indicates a very high level of awareness of the neighborhood association.

- 27.5% of the neighborhood's households paid dues in 2010; Interestingly, 75.9% of the neighborhood survey respondents were dues-paying members.

- When residents were asked how well they knew their neighbors, 61.1% chose “moderately well” and 20.4% chose “very well”
- An impressive 91.7% of respondents reported that they read the neighborhood newsletter. This includes 97.6% of dues-paying members and 73.1% of the non dues-paying members.
- Priorities: Neighbors ranked Crime Prevention by a wide margin, followed by beautification, Lafayette St. revitalization and sidewalks.

Aging

- 31.4% of residents were over the age of 65 in 1990, compared with 31.0% in 2000, and 32.9% in 2011 (U.S. Census Bureau, 1990, 2000).
- Meanwhile, the proportion of children in the neighborhood appears to have increased substantially. No children under five years-old were documented in the 2000 Census, but our recent survey found that 6.3% of the population consists of children under five.

Safety

- 50.9% characterized their neighborhood overall as “somewhat safe” while another 31.8% found it to be “safe.” 9.1% found it to be “neither safe nor unsafe” and another 8.2% found it to be “somewhat unsafe.” No respondent characterized our neighborhood as “not safe.”

This is just a tip of the survey’s iceberg—lots more info is on our website. I’d like to thank all the people who responded to the survey, Dr. Aurand and his class for doing a great job, and neighbor and board representative Mia Shargel for heading up this important project.

Beautification Doings

Along with the dry, hot, early summer weather, the Beautification Committee has slowed down our planning and gardening events. Some of the projects started during the spring are still progressing nicely. The triangle green spaces at the intersection of Limbo Lane and Old Fort Drive are getting a complete makeover. Originally the plan was to spruce up these neglected areas with new greenery. But with the help of the Tallahassee Public Works Dept. and Tallahassee Friends of Our Parks, we have been able to do much more.

New curbs have been constructed which better defines the triangles as well as lessening the erosion during the heavy summer rains. The old tree stumps and straggly vegetation will be taken out and new soil will be added. When the cooler weather comes in the fall we will begin adding new plants culled from the gardens of two of our committee members Lagran Saunders and Susanne Hunt.

During dry spells we ask neighbors who live near the plantings next to the Woodland Drives signs to water them.

Editor’s Added Notes: Rob Borger has volunteered to water the memorial trees in Old Fort Park. Julie

& Scott Carswell have adopted the plantings at the sign on North Seminole. A huge thank you to these folks! We need volunteers to keep the following areas watered:

Magnolia & Seminole sign plantings
Magnolia & Circle sign plantings

All that would be involved is a couple of gallon jugs (milk or OJ containers would work great) filled with water and poured on the plants during dry spells. If you have extra jugs, you may drop them off at Mary Frederick's house at 805 Circle Dr. You may leave them by their trashcans. You may email her marycfrederick@aol.com if you want to volunteer to water.

Old Fort Park will soon have a new doggie stand for poop bags. These new bags will be biodegradable. Many thanks to Martha Weinstein for the suggestion and who will take charge of keeping the bags stocked. The current holder will be moved to Chapman Pond. Perhaps the Canada geese will pick up after themselves.

Palms of Magnolia

The fading Palms of Magnolia Apartments has been purchased by a new property management company, Aspen Square (www.aspensquare.com/) and has been renamed Tally Square. According to an interview with the new property manager Erica Herald by our student neighborhood surveyors this spring, "significant changes" will be made to the complex; rents are being "raised significantly" and significant investments in remodeling and upgrading the apartments both inside and out, as well as new landscaping and renovations to the pool are underway. Our business neighbors along Lafayette and Magnolia indicate that changes in problematic interaction with residents with the business areas are already visibly improved. Apparently there has been immediate attention to the credentials of renters including a credit and background check.

Aspen Square specializes in (but is not limited to) student apartments, and presumably many of its new residents will be students, a boon to fast food establishments along Lafayette and a driving force toward the kinds of sidewalk coffee shops and other neighborhood pedestrian venues that we have wished for. The Woodland Drives Lafayette Street

So he called the City to inquire about how to get one installed and sent our president a proposal which she shared with the board. The board approved the proposal and voila! We have a water fountain for much-needed respite for Old Fort Park visitors. Our thanks go out to Kevin who saw a need and acted on it!

Free Neighborhood Email Updates—Are you on the Woodland Drives email list? We already have 325 of your neighbors signed up for this service. You'll get regular (2-4 times per month) emails about goings-on around the area. We never share the email addresses. Recycling Program Expanded—Yaaay! Starting now, all plastic containers that are 3 gallons or less — including yogurt cups, plastic caps and lids and butter tubs — can be tossed into the recycling bin along with glass, aluminum cans and cardboard. The only plastics not being recycled are black plastics, such as the kind used to hold plants, plastic bags and containers that have held automotive fluid, pesticides or other hazardous materials, officials said.

FAMU Way Update—Plans are in the works to expand FAMU Way in the next five years to connect to Jackson Bluff. Some neighbors wonder why we are keeping an eye on FAMU Way's expansion and redesign. Since FAMU Way becomes Oakland on its east side, we're concerned about the traffic impact of this possible cross-town throughway on both our neighborhood and Myers Park's. We have been assured from planners that FAMU Way will remain two-lane with lots of traffic circles and on-street parking to slow traffic. Traffic planners are well

aware of our concerns and have offered remediation options if necessary.

Cascade Park work is progressing!

This past May saw the reopening of our direct Downtown connection as Gaines Street from Suwannee to Meridian Streets was temporarily reopened. This connection is anticipated to remain in place through January of 2012 while work continues on the Franklin Boulevard and Lafayette Street intersection reconstruction and storm water improvements. Also in May, Myers Park Drive was reopened at the railroad crossing with an improved and safer sidewalk connection across the tracks as well as along the Department of Transportation's parking lot. This was accompanied with a rebuilt parking lot to be used for the Korean War Memorial, FDOT, and Cascade Park proper on the south side of Myers Park Drive. This parking lot was partially constructed with impervious bricks to diminish the amount of street runoff. The majority of the work for the Suwannee Street extension south to Gadsden Avenue has been completed, but the road remains closed at this time as final touches demand. Please keep in mind that the overall park project is foremost a storm water improvement project to help with flooding and runoff of Franklin Boulevard and Downtown. As such, when it is completed the area will look sparse of trees for some time and the property will be designed to flood during heavy storms, resulting in much of what is built to be covered with water, including sidewalks, seating areas, and retaining walls. Lastly, concept discussions with the public and the city have begun regarding the new pedestrian bridge over South Monroe Street beside the railroad bridge. This bridge is intended to connect the new park with planned trails to FAMU, FSU, and eventually connect to the St Marks Trail.

For a few years now, Homer Williams, a homeless man with a violent criminal background has been hanging around and asking neighbors for odd jobs. He has made some semi-aggressive verbal threats to folks and has been banned by Bill's Mini Market for his bizarre behavior. He was released from Leon County Jail on March 30 and has been seen in our neighborhood.

Often thieves observe an area prior to committing a crime, so let's help our neighbors by observing unfamiliar people walking, biking and driving through the neighborhood.

CrimeWatch works! An Indianhead-area burglar was found guilty recently and the prosecuting attorney said he will almost undoubtedly get the mandatory maximum penalty since this was his third conviction. He would have never been caught had it not been for a neighbor who noticed an out-of-the-ordinary car outside the victim's home and took a picture of the burglar's license plate. The picture led to an arrest.
